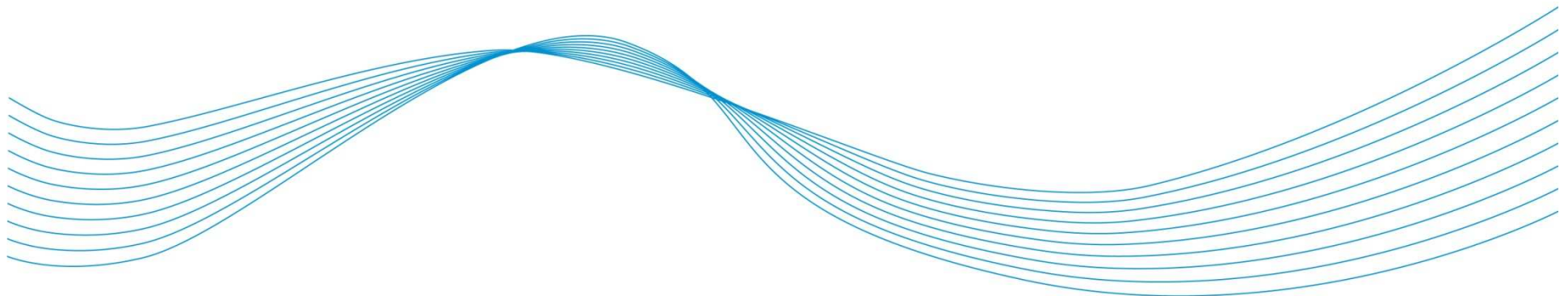
What do Members Want?

 - but little support for a big (i.e. 50%+) membership fee rise



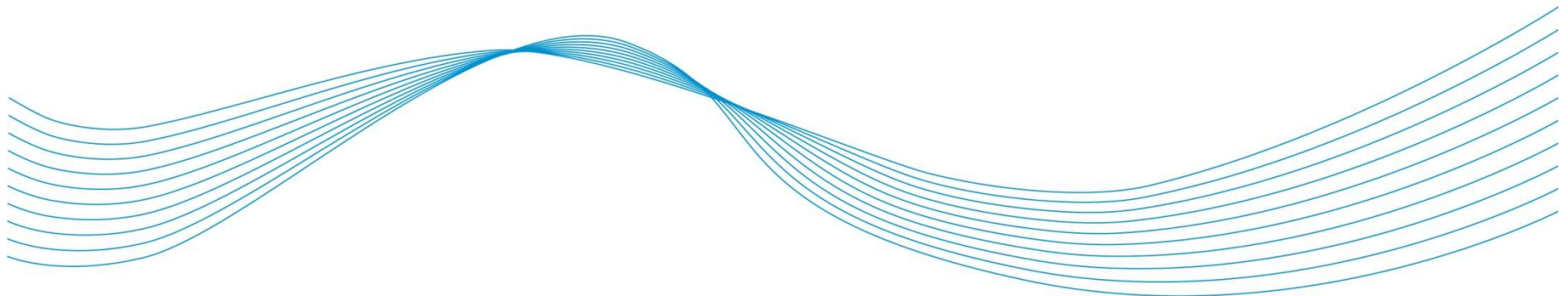
What do Members Want?

 - as the world becomes platform neutral, there are big challenges for a platform specific organisation



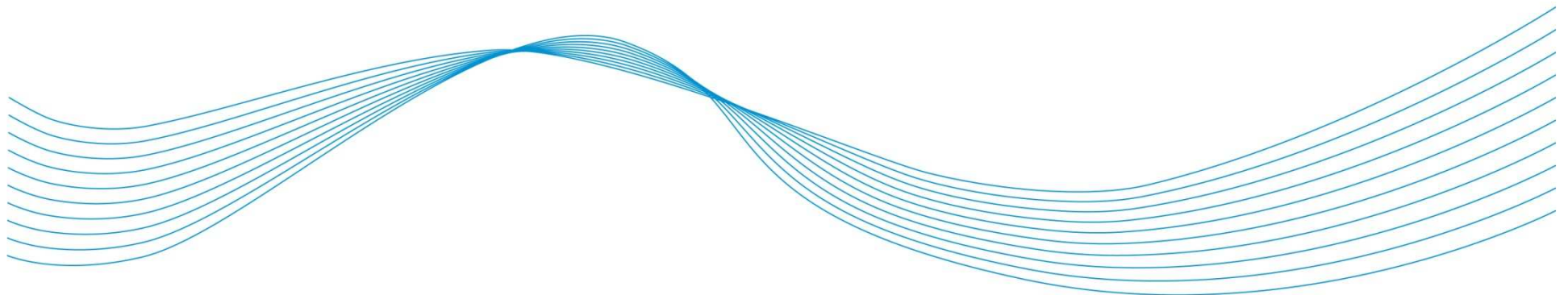
Committees and Statutes

- we reviewed the Statutes but did not identify any need to change them (they were updated in 2005)



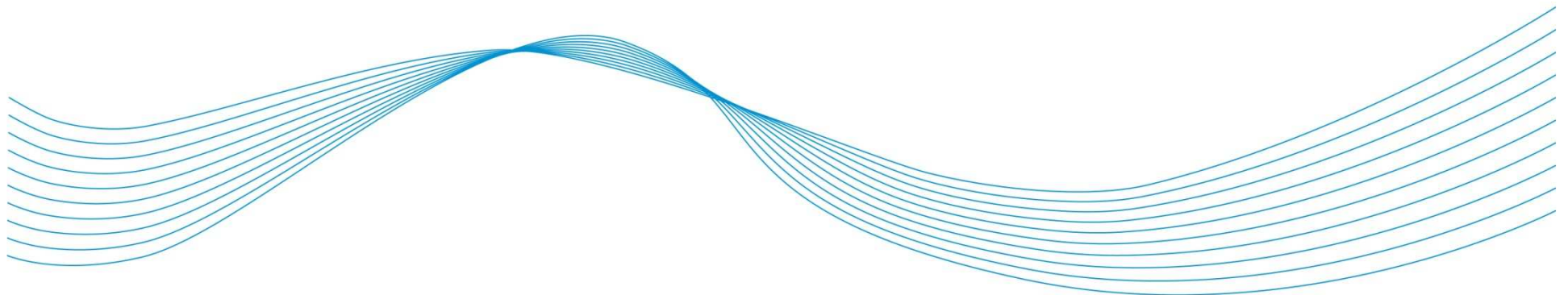
Elections

- new process to appoint people to chair committees



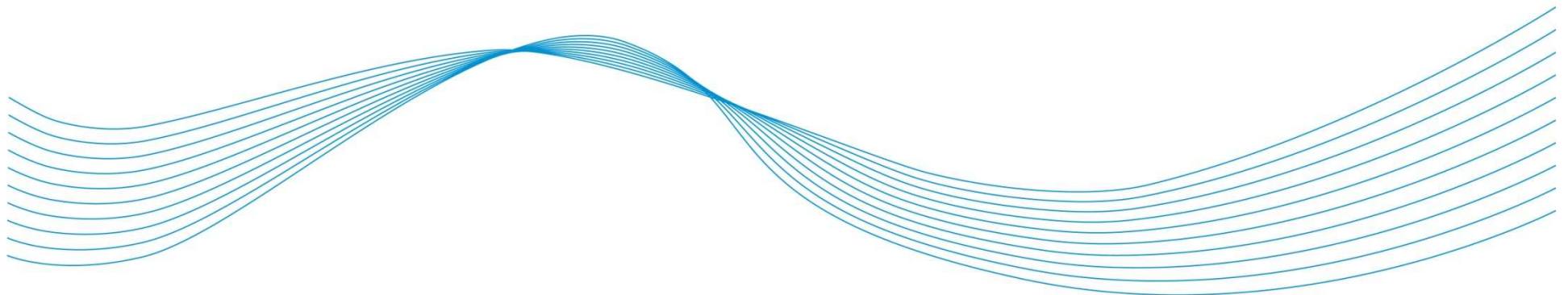
The Results - President

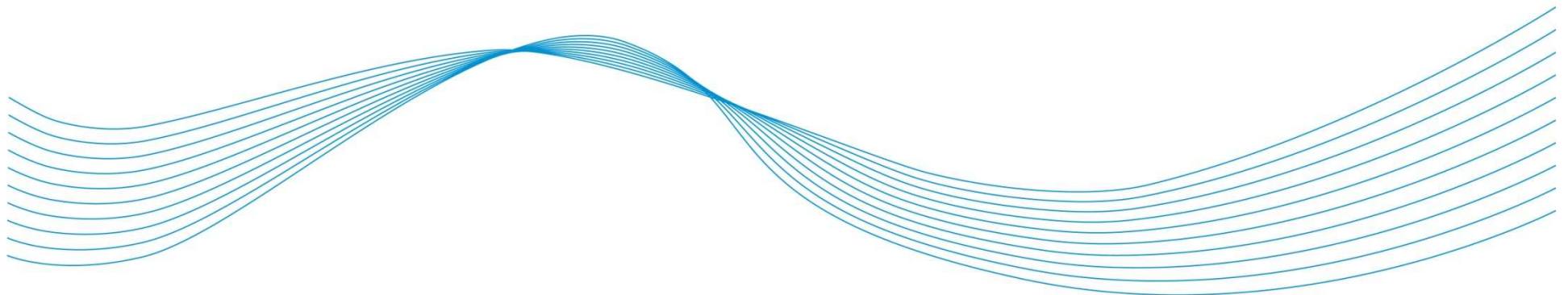
The Results – Vice Presidents

- One Vice President? Two? More than two?



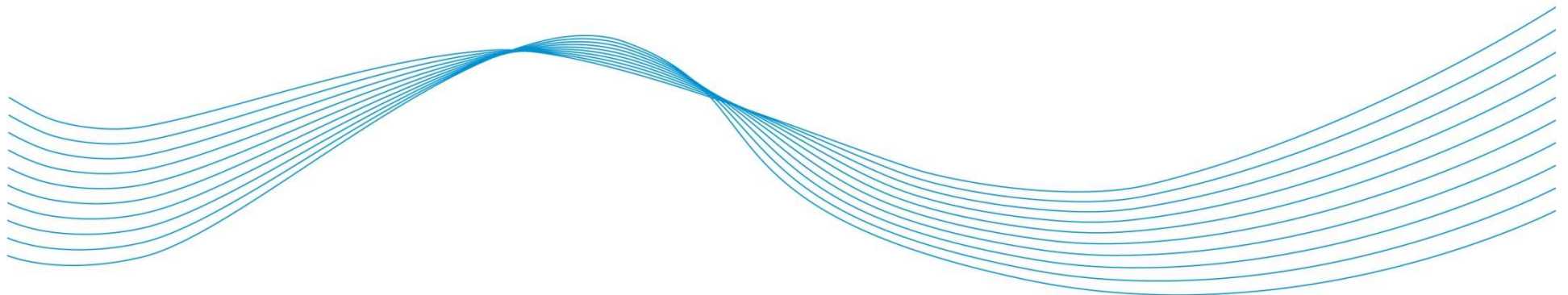
